
ADOPTED ON JUL 31 1989

BE IT FURTHER RESOLVED, that their fee of an amount not to exceed one hundred and twenty thousand dollars (\$120,000), is contingent upon the sale of bonds in connection with the above-named project and shall be reimbursed from bond proceeds.
