WHEREAS, the provisions of Council Policy No. 600-15 require that a noticed public hearing be conducted before the City Council prior to the vacation of a City Street; and


WHEREAS, the vacation of Carmel Valley Road (old alignment) east of El Camino Real has been initiated by the submission of a tentative map; and

- 1. That Carmel Valley Road east of El Camino Real, within the parcel map boundaries of Carmel Del Mar Hotel (TM 88-0941), as more particularly shown on Drawing No. 17437-B, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby authorized to be, vacated as provided under Section 66499.20½ of the California Government Code.
- 2. That this resolution shall not become effective until such time as the condemnation action in City v. Nova L. Smith,

- 4. That the City Engineer shall advise the City Clerk of the approval of the aforementioned parcel map, and that the City Clerk shall then cause a certified copy of this Resolution, with drawing, attested by him under seal, to be recorded in the Office of the County Recorder.
