WHEREAS, the proposed use would not have adverse effects on the neighborhood or community plans; NOW THEREFORE,

BE IT RESOLVED, by the Council for The City of San Diego, that in light of the foregoing, that the appeal of Billy and Patty Hammeken, by Donald R. Worley, Esq., from the decision of the Board of Zoning Appeals in partially granting a requested amendment to Conditional Use Permit C-20096, to construct additional guest quarters as part of a detached garage where such use is permitted by Conditional Use Permit only and to provide an approximate 40'0" wide driveway and turnaround within the established 25'0" front yard, where a maximum 25'0" wide driveway is allowed, is hereby granted, and the amendment to Conditional Use Permit C-20096 shall be allowed, subject to the following conditions:

- That the guest quarters shall be used solely by the occupants of the main dwelling, their guests or employees.
- 2. That the guest quarters shall not be rented, leased or sold as a separate dwelling unit and shall not contain a kitchen or cooking facilities.
- 3. That the construction of the project shall comply with all requirements of the San Diego City Building
 Inspection Department and a building permit shall be obtained.
- 4. That the Conditional Use Permit shall be signed and notarized by the applicant and returned to zoning services to be recorded with the County Recorder, within thirty (30) days of receipt of this resolution.

This Conditional Use Permit is not a permit or license, and any permits and licenses required by law must be obtained from the proper department. Furthermore, if any condition of this grant is violated, or if the same be not complied with in every respect, then this permit shall be subject to revocation.

Failure to utilize this Conditional Use Permit within the thirty-six (36) month period will automatically void the same, in accordance with Municipal Code section 101.0502.
