APPROVING MAP OF CANYON CREST HOMES.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Albert A. Kercheval, Registered Civil Engineer, entitled "CANYON CREST HOMES being a subdivision of that Portion of the Northwest Quarter of the Northwest Quarter of the Quarter Section 104 of Rancho de la Nacion, according to map thereof No. 166, by Morrill on file in the Office of the County Recorder of San Diego County, and Parcels 2, 3, and 4 of Parcel Map No. 9835, filed March 21, 1980, in the City of San Diego, County of San Diego, State of California, together with a Portion of Division Street as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Bryanview Circle and a portion of Division Street, and said street and a portion of street are hereby declared to be a public street and portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that Portion of Lot 11, marked "Reserved for Future Streets," as shown on the map, under the provisions of Government Code Section 66440.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street and portion of street is accepted on behalf of the public as heretofore stated; that said Council has rejected a Portion of Lot 11, marked "Reserved for Future Street"; together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
