RESOLUTION NUMBER R- 274180

ADOPTED ON AUG 7 1989

WHEREAS, The City of San Diego is the owner of a portion of Lot 243 of University City Manor Unit 3, Map No. 5016; and

WHEREAS, the City desires to negotiate the sale of said land to THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS, a Utah corporation sole, the adjacent owner, under the provisions of Section 22.0902 of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by independent fee appraiser on June 22, 1989, is EIGHT THOUSAND ONE HUNDRED DOLLARS (\$8,100); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No. RR- 274180, be, and the same is hereby authorized to be sold by negotiation for the amount of EIGHT THOUSAND ONE HUNDRED

DOLLARS (\$8,100) to THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS, the adjacent owner.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 274180, granting to THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS all that portion of Lot 243 of University City Manor Unit 3, Map No. 5016, as more particularly described in the grant deed.

3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

4. That the City Clerk is hereby authorized and directed to deliver the grant deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
