ADOPTED ON AUG 7 1989

WHEREAS, the Director of Intergovernmental Relations Department (IRD) has recommended in IRD Report No. 89-30 that there be approved for consideration at the League of California Cities Annual Conference two resolutions relating to (1) limits on governmental liability and compensation for victims of drunk driving accidents and (2) providing a redevelopment agency with immunity from liability for removal of toxic contamination when the situation was caused by previous owners of the property; and

WHEREAS, the Rules Committee reviewed IRD Report No. 89-30 on July 19, 1989 and approved the recommendations contained in that report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the recommendations in the Intergovernmental Relations Department Report No. 89-30 and directs the Intergovernmental Relations Department to forward to the League of California Cities The City of San Diego's request that they consider the adoption of resolutions relating to limiting governmental liability and compensation for victims of drunk driving accidents and redevelopment agencies and toxic

contamination when the league meets in annual conference in San Francisco on October 22 through 25, 1989.
