BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$75,000.00, made payable to Nettie Thomas and her attorney, Daniel Weber, in full settlement of the lawsuit and of all claims.
