RESOLUTION NUMBER R- 274224

APPROVING MAP OF OTAY INTERNATIONAL CENTER LOT
NO. 4.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "OTAY INTERNATIONAL CENTER LOT NO. 4 being a subdivision of portions of Lots 4 and 7 of County of San Diego Tract No. 4388, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 11163, filed in the office of the County Recorder of San Diego County, February 28, 1985, including portions of Siempre Viva Road, Paseo De Las Americas, Heinrich Hertz Drive and Airway Road as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Niels Bohr Court and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication those portions of Lots 1, 3, 4, 5, 7 and 8, marked "Reserved for Future Streets," as shown on the map, under the provisions of Government Code Section 66440.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities and slopes, as granted and shown on the map within the subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street is accepted on behalf of the public as heretofore stated; that said Council has rejected those portions of Lots 1, 3, 4, 5, 7 and 8, marked "Reserved for Future Street;" together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities and slopes, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
