RESOLUTION NUMBER R- 274230

ADOPTED ON AUG 7 1989

WHEREAS, an audience survey conducted in May, 1989 showed that 18.2% of 220,000 cable subscribing households in the City of San Diego watched one or more cablecast meetings of the City Council during the previous month; and

WHEREAS, The City of San Diego can no longer fund the costs for cablecast productions; and

WHEREAS, Cox Cable has made a generous offer to The City of San Diego to produce, at no cost to the City, videotaping of the Monday afternoon City Council meetings on the Council Chambers on a gavel-to-gavel basis; and

WHEREAS, Cox Cable will transmit the program to its own and to Southwestern's cable system so that it may be cablecast to subscribers Monday evenings on the government access channels; and


WHEREAS, this generous gift of cablecast production from Cox Cable will ensure that City of San Diego viewers will continue to have access to City Council meetings in their homes; NOW,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, accepts the generous gift from Cox Cable to produce Monday afternoon Council meetings gavel-to-gavel, for transmission to Cox and to Southwestern Cable viewers on late program the same Monday

evening, as more particularly described in the letter on file in the office of the City Clerk as Document No. RR- 274230 , and publicly expresses the gratitude of the Citizens of San Diego for this act of civic generosity.
