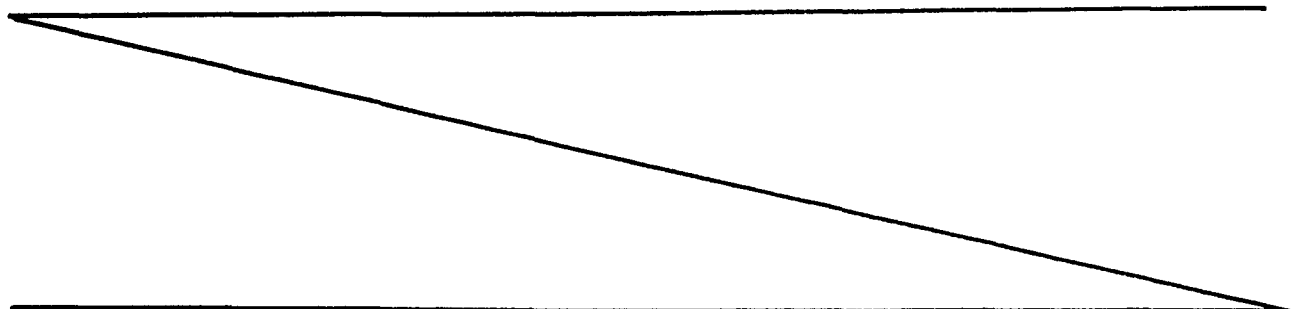
WHEREAS, by virtue of Resolution No. R-268232, the City Council created the "Metropolitan Treatment Facility Task Force," commonly referred to as the Metropolitan Sewer Task Force, on April 24, 1987; and

WHEREAS, said Task Force has been meeting regularly since its creation providing valuable review and recommendations to the City Council; and

WHEREAS, certain scientific evidence has recently been advanced that may bear on the proper level of sewage treatment; and

WHEREAS, there is an important need to review and evaluate such evidence to determine what effect, if any, it should have on the City's course of action on implementing modifications and additions to its treatment facilities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Task Force is hereby asked to review and evaluate all relevant scientific evidence bearing on the proper level of



treatment of sewage as such affects ocean dischargers and report its findings and recommendations to this Council as expeditiously as is feasible.
