- 5. That the City Auditor and Comptroller is hereby authorized to transfer \$300,000 from CIP No. 29-636, Wilson

Middle School - Acquisition, CDBG Fund No. 18523, Dept. No. 5633, Organization No. 3306, Job Order No. 000001 to CIP No. 29-574.1, Paradise Hills Community Park - Phase I.

- 6. That the City Auditor and Comptroller is hereby authorized to transfer \$300,000 from Open Space Bond Fund No. 79103 to CIP No. 29-636, Wilson Middle School Acquisition.
- 7. That the expenditure, not to exceed \$646,077 from CIP No. 29-421, Tuxedo Neighborhood Park Development (\$300,000 from Capital Outlay Fund No. 30245, \$294,642 from Capital Outlay Fund No. 30245.3; \$15,301 from PSD Fund No. 11370; and \$36,134 from PSD Fund No. 14000), is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
