RESOLUTION NUMBER R- 274241

ADOPTED ON AUG 8 1989

WHEREAS, under Resolution No. R-274001, the City Council adopted on July 17, 1989 a minimum water capacity charge of one thousand six hundred and fifty one dollars (\$1,651.00) per single family unit or its equivalent pursuant to San Diego Municipal Code section 67.72; and

WHEREAS, under the same resolution the City Council adopted on July 17, 1989 a minimum sewer capacity charge of three thousand two hundred and thirty-five dollars (\$3,235.00) per single family dwelling or its equivalent pursuant to San Diego Municipal Code section 64.0410; and

WHEREAS, a concern has been expressed that as to single family or multifamily development projects the above-referenced fees shall be effective no sooner than sixty (60) days following said action; and

WHEREAS, the City Manager has provided a thirty (30) day grace period for payment of water and sewer capacity fees under the preexisting rate schedule; and

WHEREAS, the City Council desires to provide a sixty (60) day period from July 17, 1989 through and including September 16, 1989 during which the preexisting water and sewer capacity fees shall be applicable to family or multifamily development projects; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that as to capacity fees applicable to family or multifamily development projects, said fees shall be effective sixty (60) days following the date of Resolution R-274001 thus making the effective date of said charges September 16, 1989.
