BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, dated October 11, 1988, and of J.F. SHEA COMPANY, INC., a Nevada Corporation, dated October 14, 1988, both executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 274255-1 and RR- 274255-2 granting to said City easements for public street purposes in a portion of the Northwest Quarter of Section 22 and in a portion of the Northeast Quarter of Section 21, in Township 14 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SPRINGBROOK DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
