

RESOLUTION NUMBER R- 274262

ADOPTED ON AUG 08 1989

WHEREAS, the Council of The City of San Diego has adopted the Single-Family Neighborhood Protection Ordinance (O-17250) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on July 13, 1989, the Planning Commission of The City of San Diego held a public hearing to consider approving and recommending City Council adoption of maps classifying protected single-family neighborhoods in the La Jolla, Linda Vista, Mira Mesa, Otay Mesa-Nestor, and Tierrasanta Community Planning Areas; and

WHEREAS, the Council has already adopted maps classifying protected single-family neighborhoods within the College Area and Uptown Community Planning Areas; and

WHEREAS, the Council has considered all maps, exhibits and written documents contained in the file for this project on file in the Office of the City Clerk, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby approves protected single-family neighborhood maps in the La Jolla, Linda Vista, Mira Mesa, Otay Mesa-Nestor, and Tierrasanta Community Planning Areas.

BE IT FURTHER RESOLVED, that copies of the maps designating protected single-family neighborhoods are on file in the City Planning Department.


