RESOLUTION NUMBER R- 274270

ADOPTED ON SEP 11 1989

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of PEDUS SECURITY SERVICE, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SECURITY SERVICES AT SAN DIEGO JACK MURPHY STADIUM as may be required for a period of eleven (11) months beginning October 1, 1989 through August 31, 1990, at a cost of \$8.59 per worker hour, for a total estimated cost of \$125,048.00, terms net 30 days; with options to renew contract for four (4) additional one (1) year periods, with price escalations not to exceed 5% of prices in effect at the end of each prior year.

In the event the successful bidder fails to perform in accordance with the specifications, authorizing the Purchasing Agent to terminate the contract and award to the next low bidder, and to subsequent bidders, if necessary, until a bidder is found who complies with specifications.

In the event no bidder is found who complies with specifications, authorizing the Purchasing Agent to obtain the service on the open market until the contract can be rebid.
