BE IT RESOLVED, by the Council of The City of San Diego that the low and low acceptable bids of 1. CARY K. SALES CO., INC., 2. SAN DIEGO MARINE HARDWARE, and 3. STAR TOOL & SUPPLY CO., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SMALL TOOLS as may be required for a period of one (1) year beginning September 1, 1989 through August 31, 1990, per prices on file in the Purchasing Department, as follows:

1. CARY K. SALES CO., INC., for Section I - Files, for a total estimated cost of \$2,146.10; terms 1% 20 days plus sales tax, with options to renew for two (2) additional one (1) year periods with price increases not to exceed 5% of prices in effect at the end of each prior year.
2. SAN DIEGO MARINE HARDWARE for Section VI - Screwdrivers, for a total estimated cost of \$3,486.40; terms 1% 20 days plus sales tax, with options to renew for two (2) additional one (1) year periods with price increases not to exceed 7% of prices in effect at the end of each prior year.
3. STAR TOOL & SUPPLY CO. for Section II - Gardening & Misc., Section III - Hammers & Handles, Section IV - Pliers, Section V - Shovels & Handles, Section VII - Sockets & Socket Wrench Accessories, Section VIII - Impact Sockets & Accessories and Section IX - Wrenches, for a total estimated cost of \$167,815.69; terms 1% 30 days plus sales tax, with options to renew for two (2) additional one (1) year periods with price increases not to exceed 5% of prices in effect at the end of each prior year.
