BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$487,000 within the Sewer

Revenue Fund 41506 from the Unallocated Reserve 70697 to the Metropolitan Wastewater Treatment Plant Construction Program 70292, CIP No. 46-081 METRO PUMP STATION NO. 1, 5TH and 6TH PUMPS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$487,000 from Sewer Revenue Fund 41506, CIP No. 46-081 METRO PUMP STATION NO. 1, 5TH and 6TH PUMPS, to supplement funds previously authorized by Resolution No. 273450, adopted on May 15, 1989;, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
