

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$225,000.00, made payable to Scott Stankewitsch and his attorney Gerard F. Dermody in full settlement of the lawsuit and of all claims.
