WHEREAS, the Police Department of The City of San Diego desires to continue a parent education project designated Effective Parenting and Youth Responsibility, to be funded by funds made available through the Juvenile Justice and Delinquency Prevention Program, administered by the Office of Criminal Justice Planning; and

WHEREAS, the grant in its first year provided \$55,000.00 in supplies and overtime for Juvenile Officers to expand and enhance the parenting component of the existing Juvenile Intervention and Diversion Program; and

WHEREAS, the total second year grant is \$55,000.00 with a required 15 percent (\$8,250.00) in matching funds to be provided by the City from Seized and Forfeited Assets Fund 10132; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby authorized to accept continued funding for the parent education project administered by the Office of Criminal Justice Planning, as set forth in Attachment 'A' of Resolution No. R-272725 adopted on January 23, 1989, filed in the Office of the City Clerk; and he is further authorized to execute the grant award for juvenile diversion and delinquency prevention purposes, including any extensions or amendments thereof.
