
BE IT RESOLVED, by the Council of The City of San Diego that, pursuant to San Diego Municipal Code section 66.0125, the following refuse disposal fees are hereby established for non-compacted roll-off boxes based on volume as follows:

<u>Size</u>	<u>Fees per Vehicle</u>
20 CY or less	\$75.00
21-30 CY	80.00
31-40 CY	90.00
41-50 CY	115.00
over 50 CY	140.00

BE IT FURTHER RESOLVED, that the minimum fee based upon weight for any non-compacted roll-off box shall be \$15.00 per load.
