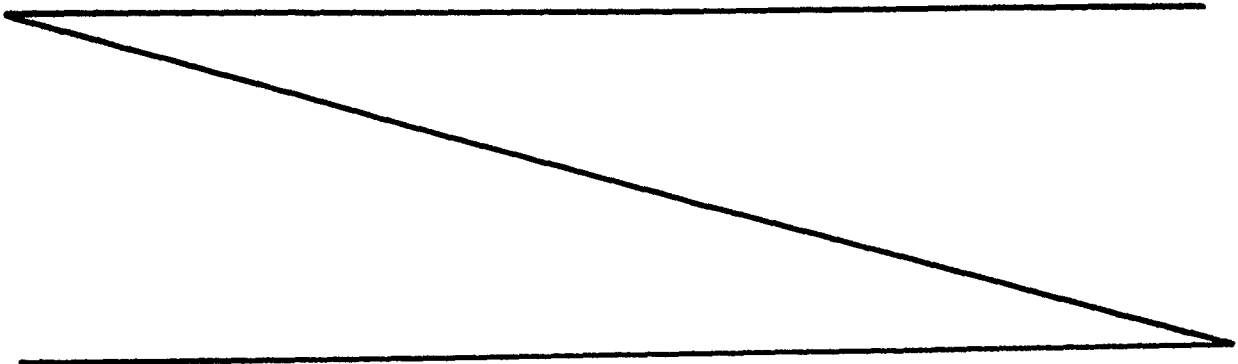

\$66,611 from the Fire Department (120), Fund 100 [\$37,186 for fiscal year 1989 and \$29,425 for fiscal year 1990],

is hereby authorized, solely and exclusively for the purpose of



providing funds for the execution of the above first amendment to agreement.
