



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with MCDANIEL ENGINEERING COMPANY, INC., a California Corporation, to provide construction documents for Friars Road Bridge, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 274339.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$350,000 from CIP 53-046.0, "Friars Road Bridge" Proposition A ½ sales tax Fund 30300, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
