
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Woodward-Clyde Consultants, to develop a closure plan and cost estimate for the closure of the South Chollas Landfill, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- **274345**.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$115,573 from Refuse Disposal Enterprise Fund 41200, CIP No. 37-250 (Methane/Leachate Control - Sanitary Landfills), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
