

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$65,520 from FY 1990 Park and Recreation Department Brush Management Program, Dept. No. 446, Org. No. 245, Job Order No. 044646, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
