BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with TECHBUILT CONSTRUCTION CORP., a California corporation, for the construction of a traffic signal at Foothill Boulevard and Fanuel Street, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR- 274365.

BE IT FURTHER RESOLVED, that the expenditure of amounts as follows: not to exceed \$45,000 from CIP No. 61-001.0, Capital Outlay Fund 30245; not to exceed \$100,000 from CIP No. 68-011.0, Proposition A Fund 30300; and not to exceed \$24,718 from CIP No. 58-001.00, Capital Outlay Fund 30245, for a total expenditure of not to exceed \$169,718, is hereby authorized and approved for the above described project.
