
RESOLUTION NUMBER R- 274371

DIRECTING STAFF TO UNDERTAKE A SIX MONTH
REVIEW OF THE AMENDED RESIDENTIAL PARKING
STANDARDS.

WHEREAS, on Sept. 25, 1989, the Council of The City of San Diego adopted revised residential parking standards by adding Section 101.0824 to the Municipal Code of The City of San Diego, among other amendments to the Municipal Code; NOW THEREFORE,

BE IT RESOLVED, that City staff be directed to undertake a review of the effectiveness of the program six (6) months subsequent to its adoption, including a comparative analysis with communities within The City of San Diego using other parking standards.
