APPROVING AN AMENDMENT TO THE LOCAL COASTAL PROGRAM BY AMENDING RESIDENTIAL PARKING REGULATIONS.

WHEREAS, On January 13, 1988, the California Coastal Commission certified with suggested modification The City of San Diego Local Coastal Program (LCP) Implementation Plan; and

WHEREAS, On April 5, 1988, the Council of The City of San Diego accepted the California Coastal Commission's certification of the City's Local Coastal Program Implementation Plan with modification; and

WHEREAS, the amendments to residential parking regulations, including the addition of Section 101.0824 to the Municipal Code, constitute an amendment to the Local Coastal Program Implementation Plan; and

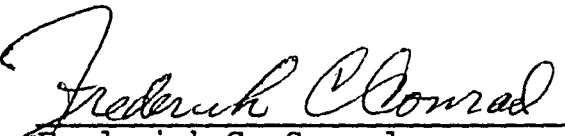
WHEREAS, the Council, hearing all public testimony, has reviewed the proposed amendment to the Local Coastal Program Implementation Plan required by the amendments to residential parking regulations; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby approves an amendment to the Local Coastal Program (LCP) Implementation Plan for The City of San Diego regarding residential parking regulations which will be implemented after certification by the California Coastal Commission.

BE IT FURTHER RESOLVED, that the Planning Director is authorized and directed to transmit this Local Coastal Program Implementation Plan amendment for residential parking regulations to the California Coastal Commission for their final and effective certification.

BE IT FURTHER RESOLVED, that this local coastal program amendment shall become effective upon the date Ordinance No. O-
0-17343 17343 becomes effective.
