WHEREAS, on June 1 and June 22, 1989, the Planning Commission of The City of San Diego held public hearings for the purpose of considering an amendment to the Tierrasanta Community Plan; and

WHEREAS, Dunfee Properties, a California corporation, and Austin Properties, a California corporation, requested an amendment to the Tierrasanta Community Plan for the purpose of redesignating a 10.15 acre site at the southwest corner of the State Route 52 and Santo Road interchange in Tierrasanta to specialized commercial use; and


