WHEREAS, the network hopes through Disability Awareness Week to educate people on various types of disabilities, on proper etiquette and with terminology when interacting with people with disabilities; and

WHEREAS, through Disability Awareness Week (September 25 through 29, 1989) the network hopes to develop public awareness about the fact that a person who has a disability is a person first, who just happens to have a disability; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the week of September 25 through 29, 1989 be and it is hereby declared to be "Disability Awareness Week" in San Diego.

BE IT FURTHER RESOLVED, that the Disability Awareness Week Network is hereby commended for its effort in bringing this to

public attention and for its efforts to dramatize the importance of understanding the world of those persons with disabilities.
