BE IT RESOLVED, by the Council of The City of San Diego that the low bid of JONES CHEMICALS, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SODIUM HYPOCHLORITE, 12.5%, IN SOLUTION, as may be required for a period of one year beginning October 1, 1989, at a cost of \$0.512 per gallon, for a total estimated cost of \$87,040.00; terms net 30 days, plus applicable California sales tax, with an option to renew the contract for one (1) additional one (1) year period, with price escalation not to exceed 15% of the bid price.

BE IT FURTHER RESOLVED, that in the event the contract vendor is unable to deliver on any occasion during the contract period, the Purchasing Agent is hereby authorized to obtain Sodium Hypochlorite from Imperial West Chemical Co., or Abcana Chemical Co., per prices on file in the Purchasing Department, or on the open market in the event emergency vendors are unable to deliver.
