1. That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an Amendment to Subdivision Improvement Agreement for WESTWOOD VALLEY UNIT NO. 2, on file in the office of the City Clerk as Document No. RR-269637, to provide for the substitution of Beck Development Company, Inc., a California corporation, for Westwood Valley Partnership, as subdivider.

2. That the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by May 2, 1990, as provided in the Amendment to Subdivision Improvement Agreement, on file in the office of the City Clerk as Document No. RR-274396.

3. That Irrevocable Standby Letter of Credit No. I-96828 issued by Security Pacific National Bank in the amount of \$445,780.00 is hereby accepted as the surety for the required improvements in the subdivision, is substituted as Exhibit C to the agreement, and Bond No. BD 79 00 518952, issued by Allied

Mutual Insurance Company, in the amount of \$445,780.00, is hereby released.
