

RESOLUTION NUMBER R-271108 ADOPTED ON SEP 181989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Security Pacific Securities, Inc./Connell & Associates, to assist in the development of specific financing details on the Open Space Park Facilities District, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- $\frac{274408}{408}$.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$26,950 for financial advisory services relating to the above financial plan and a sum not to exceed \$1,500 for reimbursable expenses is hereby authorized. In the event that bonds are issued, the total fee for the financial plan and financial advisory services related to the bond issuance are approved in an amount not to exceed \$113,950, and which shall be reimbursed from the proceeds of the bond sale, together with all previous expenditures related to the costs of such issuance and professional services related thereto.



BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserves, upon advice of the administering department.
