
RESOLUTION NUMBER R- 274411

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$12,000 from Capital Outlay other fund, fund 302453 to CIP 33-084.0, Underground Hazardous Materials Storage Tanks.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,850,000 from CIP 33-084.0, Underground Hazardous Materials Storage Tanks; \$402,419 for professional services and \$1,447,581 for construction, administration, and related project costs, is hereby authorized.
