WHEREAS, honoring Dr. King by renaming State Highway 94 would be a symbol of his dream of freedom, peace and justice for all and serve as a constant reminder of his contributions to the state, nation and world; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego, that the Council expresses its strong support to the proposal of Senator Deddah and Assemblyman Chacon to name State Highway 94

within The City of San Diego in honor of Dr. Martin Luther King,
