
ADOPTED ON SEP 18 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of DE LA FUENTE BUSINESS PARK, INC., a California corporation, executed in favor of The City of San Diego, bearing date of July 21, 1989, a copy of which deed is on file in the office of the City Clerk as Document No. RR-274427, granting to said City an easement for public street purposes in portions of the Southeast Quarter of Section 35, Township 18 South, Range 1 West, San Bernardino Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named AVENIDA DE LA FUENTE NORTE, AVENIDA DE LA FUENTE SUR, OTAY CENTER DRIVE and HARVEST ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
