WHEREAS, Gordon Murdoch was born in Scotland and came to San Diego in 1955; and

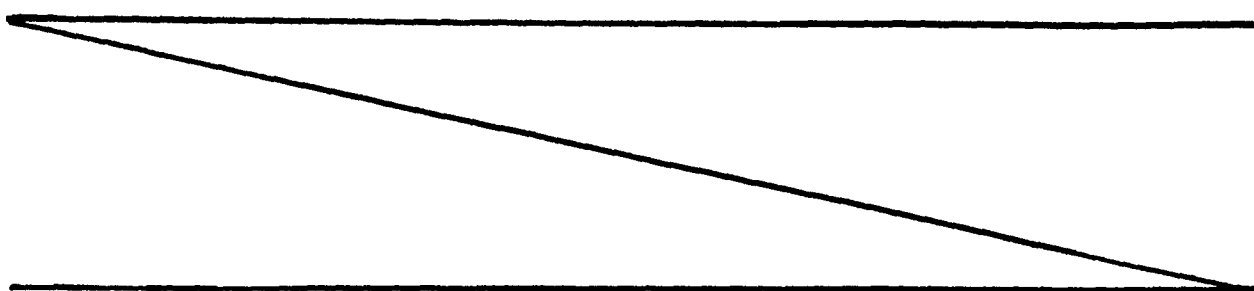
WHEREAS, Gordon graduated from San Diego State University in 1966 with a degree in engineering; and

WHEREAS, he rose through the ranks of the department and in 1984 was named Director of the Building Inspection Department, where he earned the respect and admiration of all who have served under him; and

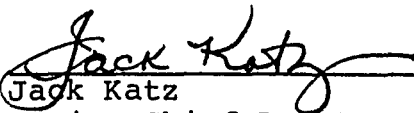
