BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$246,532 from Fund 30300 (Proposition A), CIP No. 68-010 CONSTRUCT TOP 10-15 PRIORITIZED TRAFFIC SIGNALS EACH YEAR, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 68-010 CONSTRUCT TOP 10-15 PRIORITIZED TRAFFIC SIGNALS.
