

RESOLUTION NUMBER R- 274438

ADOPTED ON SEP 25 1989

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for EIGHTH AVENUE IMPROVEMENTS FROM L STREET TO HARBOR DRIVE, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on SEP 25 1989, and bearing official Document No. 00118902, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for EIGHTH AVENUE IMPROVEMENTS FROM L STREET TO HARBOR DRIVE.

BE IT FURTHER RESOLVED, that the City Auditors and Comptroller is hereby authorized to transfer \$348,096 (\$85,000 from Capital Outlay Fund 30245, CIP No. 64-004 ANNUAL ALLOCATION - RAILROAD WARNING DEVICES AND \$263,096 from Proposition "A" Fund 30300, CIP No. 58-004 ANNUAL ALLOCATION - MISCELLANEOUS REQUIREMENTS - CITY STREETS to CIP No. 52-353 EIGHTH AVENUE IMPROVEMENTS - FROM "L" TO HARBOR DRIVE.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstance warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$270,000 per executed Agreement (R-273017) with the Metropolitan Transit Development Board (MTDB) for Proposition "A" Fund 30300, CIP No. 52-353 EIGHTH AVENUE IMPROVEMENTS - FROM "L" TO HARBOR DRIVE is hereby authorized solely and exclusively for said project and related cost, and authorizing the Auditor and Comptroller, upon advice from the administering Department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,314,000 (\$121,904 from Capital Outlay Fund 30245 and \$1,192,096 from Proposition "A" Fund 30300) from CIP No. 52-353 EIGHTH AVENUE IMPROVEMENTS - FROM "L" TO HARBOR DRIVE is hereby authorized solely and exclusively for said project and related cost, and authorizing the Auditor and Comptroller, upon advice from the administering Department, to transfer excess budgeted funds, if any, to the appropriate reserves.
