
RESOLUTION NUMBER R- 274462

ADOPTED ON SEP 25 1989

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of CHEMWEST INDUSTRIES, INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of FERRIC CHLORIDE as may be required for a period of one (1) year beginning November 1, 1989 through October 31, 1990, at a delivered price of \$0.1131 per dry pound, for a total estimated cost of \$3,166,800.00; terms net 30 days, plus sales tax, with an option to renew the contract for three (3) additional one (1) year periods with price escalation not to exceed 15% of the previous year's price.

BE IT FURTHER RESOLVED that in the event that the Contractor fails at any time during the contract period to deliver material meeting specifications, the Purchasing Agent is hereby authorized to obtain ferric chloride from Imperial West Chemical Co. under the terms of the emergency price clause in the specifications, at a cost of \$0.16 per dry pound, delivered, terms net 30 days, plus sales tax.
