RESOLUTION NUMBER R- 274476

ADOPTED ON OCT 2 1989

WHEREAS, The California Right to Housing Campaign, was launched at the Housing California 1989 State Conference, where it was enthusiastically endorsed by over 500 participants, including non-profit housing developers, shelter providers, public officials and other community leaders from throughout California; and

WHEREAS, 25% of San Diego City's households are very low income, and in 1988, 60% of San Diego's population were renters, and these unusually high figures are directly related to the alarming decrease in homeownership; and

WHEREAS, on Saturday, October 7th, people from all parts of the Nation, including San Diego County, will gather at various sites in Washington, D.C. to rally for increased federal support for affordable housing; and

WHEREAS, since 1980, the budget for all federal housing assistance programs has been cut by more than 75%, from \$32 billion to \$7.5 billion a year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby encourages Congress to provide federal assistance to make

it possible for local governments and the private sector to jointly produce affordable family housing at levels necessary to assure that the need will be met.
