

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$20,000.00 from the Transient Occupancy Tax Unappropriated Reserve for Balboa Park Improvement Projects, Fund No. 102242, is hereby authorized, solely and exclusively for the purpose of providing funds for said services.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer unexpended funds, if any, to the appropriate reserves upon advice of the Park and Recreation Director.
