Michael Underhill	Comm. & Elec.	\$253.13	Mr. Underhill is a Traffic Technician. He suggested using the suggestions design for temporary traffic signal. This is a full award based on a projected first year savings of \$1,687.50.
Donald Boyett	Utilities	\$320	Mr. Boyett is a WWPO. He suggested using a sludge baffle in front of the decant screen. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Kenneth Martinosky	Equipment	\$447.40	Mr. Martinosky is a Service Writer. He suggested using all metal brake knob for refuse trucks. This is a partial award based on a projected first year savings of \$2,982.65.
