Dennis Boisvert	Utilities	\$ 50	Mr. Boisvert is a Plant Maintenance Mechanic. He suggested using a water injector to keep dust from going into air at the Alvarado Plant. Although savings are difficult to identify, this is considered to be a significant operational improvement.
William Cross	Fire	\$ 50	Mr. William Cross is a Fire Engineer. His suggestion to post allowable calling prefixes near telephones led to the issuance of a bulletin reminding all Fire personnel to refer to the phone book prior to placing personal calls. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Zenaida Smith	Property	\$127.30	Ms. Smith is a Data Entry Operator. She suggested using a stamped form to handwrite information on lease information print-outs. The actual savings are \$424.32 for the first year. This is a full award.
