

RESOLUTION NUMBER R- 274498

ADOPTED ON OCT 3 1989

WHEREAS, on January 13, 1988, the California Coastal Commission certified The City of San Diego Local Coastal Program (LCP) Implementation Plan; and

WHEREAS, on April 5, 1988, the Council of The City of San Diego accepted the California Coastal Commission's certification of the City's Local Coastal Program; and

WHEREAS, on October 17, 1988, the City of San Diego assumed responsibility for issuing coastal development permits in certified areas of the coastal zone; and

WHEREAS, the Local Coastal Program is intended to be carried out in a manner fully in conformity with the Coastal Act; and

WHEREAS, the Coastal Act requires that all amendments to the Local Coastal Program be certified by the California Coastal Commission; and

WHEREAS, the scope and breadth of land use actions which require amendments to the City of San Diego's Local Coastal Program are extensive; and

WHEREAS, many land use decisions which require a Local Coastal Program amendment are of City-wide significance and not specifically intended to address coastal issues; and

WHEREAS, the City anticipates the need for several amendments to the Local Coastal Program each year; and

WHEREAS, all amendments to the Local Coastal Program require a resolution authorizing transmittal of the amendment to the Coastal Commission; and

WHEREAS, the procedures for processing Local Coastal Program amendments could be simplified by the adoption of a standing resolution authorizing and directing the Planning Director to transmit all Local Coastal Program amendments, which have been adopted by the City Council, to the Coastal Commission; and

WHEREAS, all Planning Commission and City Council actions which involve a Local Coastal Program amendment will continue to be represented as such in the public notice and the report to the Planning Commission and City Council; and

WHEREAS, a failure to describe a Local Coastal Program amendment as such, in either a public notice or report, will give the Coastal Commission grounds to invalidate the applicability of the transmittal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Director is authorized and directed to transmit to the California Coastal Commission all amendments to the City's Local Coastal Program which have been adopted by the City Council.


BE IT FURTHER RESOLVED, that the effective date of any Local Coastal Program amendment, with respect to the action of the California Coastal Commission, shall be stated in the ordinance or resolution adopted by this Council which approves any such amendment.

BE IT FURTHER RESOLVED, that the City agrees to issue coastal development permits consistent with the certified LCP as amended.

BE IT FURTHER RESOLVED, that this resolution shall accompany all Local Coastal Program amendments transmitted to the Coastal Commission, except where the City Council elects to adopt an alternative resolution of transmittal.
