WHEREAS, Big Bear Markets is a San Diego based, family owned business that has been in operation for forty-five years; and

WHEREAS, Big Bear Markets is the first supermarket chain in the nation to adopt a corporate commitment to alerting its customers to environmentally preferable products and the importance of biodegradability and recyclability in packaging materials; and

WHEREAS, Big Bear Markets will return to paper bags with a 38% recycled paper content and pay its customers \$.02 for each large bag brought back to the store to encourage reuse of paper bags; and

WHEREAS, Big Bear Markets will use paper containers in the service deli department and cushioned molded paper egg cartons made from recycled paper to reduce the use of foam plastics which are damaging to the environment; and

WHEREAS, Big Bear Marketing has adopted "I Love a Clean San Diego" as the beneficiary of donated proceeds from beverage containers brought to their 20/20 recycling centers; NOW,

proclaims and declares October 1989 to be "BIG BEAR MARKETS  
APPRECIATION MONTH" in San Diego.
