That the low bid of \$38,883.20 by BENNY WRIGHT BACKHOE, a sole owner, meeting specifications for CONSTRUCTION OF THE ALLEY BLK. 53, FAIRMOUNT ADDITION STORM DRAIN, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 119307.

2. That the City Manager is hereby authorized, if circumstances warrant, to finance or refinance this project with tax exempt securities.

3. That the expenditure of \$10,800 from Capital Outlay Fund 30245, CIP No. 17-003 ANNUAL ALLOCATION - SEEPAGE PROBLEMS to supplement funds previously authorized by Resolution No. 274166, adopted on August 7, 1989, is hereby authorized solely and exclusively for providing funds for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
