
RESOLUTION NUMBER R- 274520

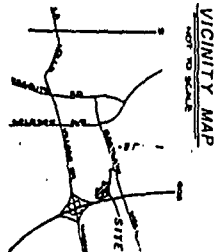
