BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$797,700 from Water Revenue 41502, CIP 73-250 Otay Mesa Reservoir, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
