WHEREAS, at approximately 3:15 p.m. on Friday, August 11, 1989 at Skyline Community Park a gang-related altercation took place involving firearms; and

WHEREAS, seventy-five children were present, participating in a recreation program; and

WHEREAS, Recreation Center staff, including Center Director Stacy McKenzie and Recreation Leaders Dwight Magee, Anthony Hampton, Sondra Harrison, Gary Chambers, Stephanie Hill and Annette Bell all began moving the children to safety; and

WHEREAS, Recreation Leader Sondra Harrison was injured by a thrown object while escorting the children to safety; and

WHEREAS, Recreation Leader Dwight Magee risked his own well being by exposing himself to crossfire of gunshots to rescue one remaining child and was himself seriously wounded; NOW, THEREFORE,


