WHEREAS, at approximately 3:15 p.m. on Friday, August 11, 1989 at Skyline Community Park a gang-related altercation took place involving firearms; and

WHEREAS, seventy-five children were present, participating in a recreation program; and

WHEREAS, Recreation Leader Dwight Magee began moving the children to safety; and

WHEREAS, Dwight Magee risked his own well being by exposing himself to crossfire of gunshots to rescue one remaining child and was himself seriously wounded; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, for and on behalf of the people of San Diego, that the brave and exemplary behavior of Dwight Magee in the performance of his job preventing loss of life and/or serious injury to the public, is highly commended.

BE IT FURTHER RESOLVED, that the City Council hereby expresses its deepest appreciation and gratitude to Dwight Magee for exhibiting and performing a high standard of public service and dedication to the people of San Diego.
